Nexus Analysis, Voluntary Disclosure

Issue: P Co. was selling diagnostic equipment into 25+ states without properly collecting or remitting Sales/Use tax or filing Income tax returns. A publicly traded company purchased P Co. with a significant holdback for tax issues.

Benefit: Correct Past, Present, and Future Tax Filing. Miles Consulting analyzed P Co. nexus activities, estimated liabilities, established a work-out plan and negotiated with states to pay the correct tax, ultimately reducing the holdback by almost \$1 million.
